Suspension:

A suspension will not be added if there is an open suspension on the driving record with the same case number.

To issue or reissue a suspension send a "2" in field 1, transaction type; DHSMV must have a restore date on the driving record to reissue.

Clearance:

The following chart outlines the fields required to provide notice of compliance to DHSMV:
