SUBJECT: UTC Data Integrity Grant Workshops

The Department of Highway Safety and Motor Vehicles, the Clerk of Courts and Law Enforcement Agencies are jointly responsible to account for all uniform traffic citations in accordance with rules and procedures promulgated by the Department. The Department is committed to the improvement of the data quality, accuracy, and timeliness of uniform traffic citation data collected and transmitted in conjunction with the Traffic Citation Accounting Transmission System (TCATS). Therefore, The Department applied for and received the UTC Data Integrity Grant from the Department of Transportation.

The UTC Data Integrity Grant was awarded to improve the data quality on Florida driver records and allows the Bureau of Records to provide regional workshops with the Clerk of Courts that focuses on the importance of traffic data, the TCATS process and dataflow, the new ICD 6.0.1, and how to correct TCAT errors to ensure accurate reporting to the Department.

UTC Senior Liaison Officers Christine Burnette and Richie Frederick recently conducted the first workshops in Ocala and Orlando. There were 35 representatives from the Clerks of Court in nine counties in attendance. The next workshops are scheduled at the following locations:
