| Type of License | Licensing Period | Renewal notice and renewal application are e-mailed by the Department. | Annual Renewal: Completed renewal application, fee and required documents must be submitted to the Department before the license expiration date to avoid delinquent fee or applying for a new license. | Delinquent Period: License can be renewed with a delinquent fee. |

| Franchised motor vehicle dealer (VF) | January 1 - December 31 | 14-Oct | License must be renewed by January 1 | 45 days delinquent period after license expiration date (until February 14) |
| Franchised motor vehicle service facility (SF) | January 1 - December 31 | 14-Oct | License must be renewed by January 1 | 45 days delinquent period after license expiration date (until February 14) |
| Independent motor vehicle dealer (VI) | May 1 - April 30 | 14-Feb | License must be renewed by May 1 | 45 days delinquent period after license expiration date (until June 14) |
| Wholesale motor vehicle dealer (VW) | May 1 - April 30 | 14-Feb | License must be renewed by May 1 | 45 days delinquent period after license expiration date (until June 14) |
| Motor vehicle auction (VA) | May 1 - April 30 | 14-Feb | License must be renewed by May 1 | 45 days delinquent period after license expiration date (until June 14) |
| Salvage motor vehicle dealer (SD) | May 1 - April 30 | 14-Feb | License must be renewed by May 1 | 45 days delinquent period after license expiration date (until June 14) |
| Mobile home dealer (DH) or mobile home broker (BH) | October 1 - September 30 | 14-Jul | License must be renewed by October 1 | License expires on September 30. Licensee must pay the original fee to renew after the expiration date |
| Recreational vehicle dealer (RV) | October 1 - September 30 | 14-Jul | License must be renewed by October 1 | License expires on September 30. Licensee must pay the original fee to renew after the expiration date |
| Used Recreational vehicle dealer (RU) | October 1 - September 30 | 14-Jul | License must be renewed by October 1 | License expires on September 30. Licensee must pay the original fee to renew after the expiration date |
| Motor Vehicle Manufacturers (MV), Importers (MI) and Distributors (MD) | October 1-September 30 | 14-Jul | License must be renewed by October 1 | License expires on September 30. |
| Recreational Vehicle Manufacturers (MR), Importers (RI), and Distributors(RD) | October 1-September 30 | 14-Jul | License must be renewed by October 1 | License expires on September 30. |
| Mobile Home Manufacturers (MH) | October 1-September 30 | 14-Jul | License must be renewed by October 1 | License expires on September 30. |
