Subject: Important Notice for All Licensed Auction Dealers in the State of Florida

It was recently brought to the attention of the Department that licensed mobile home dealers with a recreational vehicle endorsement on their license are being denied entry at auctions to transact business in recreational vehicles.

Section 320.771(8), Florida Statutes provides, "Any mobile home dealer licensed pursuant to s. 320.77, may apply to the department for authority to sell recreational vehicles. The mobile home dealer shall file an application required by this section and shall be governed by the licensing provisions contained herein. No additional license fees or bond shall be required for issuance of this endorsement to the mobile home dealer's license." However, such dealers do provide proof of garage liability insurance coverage and a copy of their agreement with the recreational vehicles manufacturer, importer or distributor for the particular line-make to the DMV Regional Office responsible for their dealership.

In accordance with the above, mobile home dealers who sell new and/or used recreational vehicles are issued a mobile home dealer's license with a recreational vehicle endorsement that is shown on the face of their mobile home dealer's license. (A sample of the mobile home dealer's license with the recreational vehicle endorsement is attached for your information). What this means is that mobile home dealers with a recreational vehicle endorsement on their license may transact business in recreational vehicles with a motor vehicle auction as defined in s. 320.27(1)(c)4. They are not required to have a separate recreational vehicle dealer's license to transact at an auction.
