



# COMMERCIAL VEHICLE AND DRIVER SERVICES E-FILE REQUEST

The Division of Motorist Services, Bureau of Commercial Vehicle and Driver Services, is pleased to announce e-filing for International Registration Plan (IRP) and International Fuel Tax Agreement (IFTA) transactions. Using the form below, you may now apply to file your IFTA tax returns, order decals and renew your IFTA account, renew your IRP account, add vehicles and jurisdictions to your IRP account, and pay for any of these transactions via the internet. Other transactions will be added as they become available. We hope you will enjoy the convenience of using the electronic system and appreciate the assurance that your transaction is complete, accurate and timely received.

An important benefit to this process is that you will have electronic access to your account and will be able to verify all of your account information.

In order to access your account, you will need a Login Identification (Login ID) Number and A Personal Identification Number (PIN). For your protection, your original signature is required on the form. You may use a Power of Attorney to complete this form.
