

Dear Sir or Madam,

In response to questions received, the subject Invitation to Bid is amended as follows:

Questions submitted by: ThyssenKrupp Elevator

#1 How can we obtain the price sheet from the previous bid?

Answer to #1. The price sheet has been attached with this addendum.

#2. Have all twelve (12) elevators been inspected? If they have been inspected have all the violations been corrected?

Answer to #2.: Yes, all twelve (12) elevators have been inspected and all violations have been corrected.

#3. During a recent site survey three (3) items were discovered as potential large repair items.

Elevator # 6: Overhead deflector bearings.

Elevator # 7: Motor bearing going bad.

Elevator # 11: Jack sill replacing and pit clean up.

Will a pre-maintenance estimate be allowed with the maintenance proposal or will the elevator provider have to absorb repair cost in bid estimate.

Answer to #3: There will not be a pre-maintenance estimate; any repair cost must be included in the bidder's proposal price.
