| SUBJECT: New Process for Packing Personalized License Plates | |

Overview:

PRIDE has enhanced the way personalized license plates are packaged to the counties each month.

The new process will begin with the September end-of-month shipments.

Details:

Personalized license plates will be shipped to the same location as in the past.

The new addition is each box will have county and agency specific labels.

For personnel responsible for processing the shipments, they will no longer need to open each box to determine which plates go to which office. The inside shipper will remain the same.

Attached are examples of the outside label for the box(es) and the inside shipper.
