**Overview:**


A pilot site deployment of system changes to the Florida Real-time Vehicle Information System (FRVIS) for the SB 2500 will be made on Sunday, October 27, 2019.

**Details:**

The pilot sites include 46/03, 3/11, 01/14. If the pilot is successful on October 28, 2019, then the change will be available statewide on October 29, 2019.

**Legislation SB 2500 - FRVIS – License Plate Agency Network Access**

This change in FRVIS will require License Plate Agencies (LPA) to cover the cost of their business’s network/circuit access. Charges associated to these transactions will be included in the remittance total owed to FLHSMV and will be paid through the normal payment process. Here are examples of how the circuit billing transactions appear on the FRVIS Payment queue screen and the end-of-day reports.
