SUBJECT: WRAP 4200 Software Release Update for Heavy Truck Registration Renewals	

Overview:

The Florida Department of Highway Safety and Motor Vehicles (FLHSMV) is performing updates to its registration renewal systems to comply with HB 87. The updates will be deployed statewide on Tuesday, September 1, 2020 at 12:00 a.m. (ET). The Systems Evaluation Unit will conduct production testing. A TAC notice for the release will also be issued to show the availability of services.

The vendors that use these renewal systems received updated technical information related to the changes. The affected renewal systems are:

- Florida Real-time Vehicle Information System (FRVIS)
- Motor Vehicle Renewal File (JSON)
- Mobile App
- Virtual Office
- Motor Vehicle Kiosks
- Renewal Eligibility Service

The Motor Vehicle Renewal File (JSON) will only have one renewal option for January, February and March birth months and the fees will be either for 13-month, 14-month or 15-month renewals. April through December birth months will have two renewal options with the appropriate fees.

Details:

WRAP 4200 – HEAVY TRUCKS. This change will allow heavy truck owners to renew their truck registration up to their birth month in 2021 or 2022. This change affects the registration renewal date but will not change any fees or registration uses.

Beginning September 1, 2020, owners with a birth month of January through June may choose to renew their registration for the timeframe from either December to their birth month or December through their birth month plus an additional 12 months. For owners with a birth month of July through December may choose to renew their registrations for either the timeframe from December to their birth month or December through their birth month plus an additional 12 months. The renewal options may be performed online or in an office. Please see the chart below to determine monthly renewal options.

January through March owners have one option via Virtual Office, myFlorida mobile app, MV Express Kiosk, and two options in the office. For example, an owner with a January birth month can renew for 13 months online and 1 or 13 months in the office.

Similarly, April through December owners have two options via Virtual Office, myFlorida mobile app, MV Express Kiosk and in the office. For example, an owner with an April birth month may renew for 4 or 16 months online or in the office. Please see the chart below to determine the monthly renewal options.
