****Passing on enter/exit side while bus is stopped (more egregious)*** - This violation occurs when a vehicle passes a stopped school bus on the side where kids are let on and off the bus, meaning they occasionally drive up on the sidewalk. This is a moving violation that incurs three points on a license, a minimum fine of \$265 and a mandatory court appearance. Typically this is considered aggressive driving.

**** Failure to stop for a school bus*** - This violation occurs when a vehicle passes a school bus on the side where children are not entering/exiting while the bus is stopped with the STOP sign out. It includes drivers who do not stop in either direction if no five feet barrier (such as a median) exists on the road. This violation comes with a minimum fine of \$165, three points on your license and mandatory Basic Driver Improvement (BDI) course.
