## Introduction

The purpose of this grant is to improve the completeness and accuracy of Crash Report Data and Uniform Traffic Citations (UTC) by facilitating statewide trainings with all Clerk of Court offices. This training focuses on Uniform Traffic Citations (UTC).







# **Training Objectives**

Identify the administration, issuance, processing, and reporting of UTCs.

Accurately transmit citation and disposition data through the Traffic Citation & Accounting Transmission System (TCATS).

Recognize common errors and solutions for accuracy when transmitting UTCs through TCATS.






## UTC Process Cycle

**Statutory Authority** 

Florida Highway Safety and Motor Vehicles (FLHSMV) is responsible for the administration of all Uniform Traffic Citations

**Statutory Authority** 

The Clerk of Court shall report the following to FLHSMV within <u>10 days</u>:

- Payment of the civil penalty/defendant has admitted to the infraction
- Charge results in a hearing the official certifies the final disposition
- All errors reported must be corrected after the notification of the error



#### **FLHSMV issues citations to:**

- > State Attorneys
- > COC Clerks
- > Tax Collectors
- Red Light Camera
- > Toll Authority

#### **Types of Citations**

- Standard Uniform Traffic Citation
  - Red Light Camera
  - ➤ Toll
- Driving under the influence UTC

#### **Accountability**

All agencies are jointly responsible and play an important part in accounting for all UTCs issued.



## **Clerk of Courts Shall:**

- Receive and account for citations issued by law enforcement agencies
- Dispose citations by collection of fees or normal court process
- > Notify law enforcement of all UTC errors that requires correction
- Notify FLHSMV of failure to comply (FTC)
- Submit final disposition of UTC to FLHSMV within 10 days of disposition
- Submit UTC corrections via TCATS within 10 days of error notification



#### Florida Court Clerks and Comptrollers Shall:

- > Send UTC files to the Department via TCATS
- Provide the Interface Control Document(s) (ICD)
- > Validate data fields based on appropriate rules
- > Verify UTC numbers have 7 characters

The Citation Interface will be used to transmit citation information electronically from a county to TCATS central site. The format can be fixed witdth or variable length records with fields separated by "|".


### **TCATS Interface Control Document**

- Uniform format for electronically transmitting UTC and disposition data

#### Files that FAIL Validations

- > If the COC's validation checks fail, the clerk will receive a local error in their CMS
- If FCCC's validation checks fail, the clerk will receive a hard CIT or DIS error
- > If FLHSMV's validation checks fail, the clerk will receive a hard ARR, UTC, or D6 error

#### **Files that PASS Validations**


- > Update the citation inventory system
- Disposition will post to the driver's record (should update within 2 days)
- Exceptions: Not guilty, Dismissal, Verdict B, or Nolle Prosequi verdicts are not posted to the record

# **UTC Voids**



When reporting citations for voids the agency must submit a letter on agency letterhead. <u>The letter must include the list of the citations to void and reasons</u> for the voiding. The chief administrative officer or a designated official must sign and date the letter. The agency should report the voids using one of the following options:

#### NOTE: The agency must return all copies of the citation(s) and the letter.

NOTE: Email must include the letter and an excel spreadsheet listing all the citations in alphanumeric order in the Consolas font. Once FLHSMV approves the voids the agency can destroy the citations by cross cut shredding or incineration.

## UTC Voids cont.

Applies only to spoiled, mutilated, or otherwise <u>unusable</u> citations

Does not apply to:

• Citations already issued to a violator

• Citations already transmitted to the Clerk of Court

• Citations transmitted to the Clerk of Court and dismissed



#### **UTC Transmittals**

#### **Statutory Authority**

The chief administrative officer shall transmit, on a form approved by the department, within 5 days after submission of the original, groups of issued citations and transmittal data to the court. Batches of electronic citations containing a replica of citation data may be transmitted to the court in an electronic fashion, in a format prescribed by the department within 5 days after issuance to the violator

- Once submitted, the indefinite revocation will be updated with the length of revocation and the release date will serve as the revocation effective date



# **Commercial Driver Licenses**



### CDL Learners' Permit – New Issuance



- Must have licensed driver 21 years or older, with a CDL equivalent to, or higher than, the type of vehicle indicated on the permit
- May only be issued by the state of domicile [49 CFR §383.212]
- Must self-certify and, if required, provide a current Medical Examiner's Certificate – [49 CFR383.71(2)(ix)]
- Ages 18, 19 and 20 must be restricted to "Intrastate Only" (Restriction 2).
- May not obtain a Hazmat Endorsement



### Violations Requiring a UTC

It has come to FLHSMV's attention that UTCs have not been written to CDL/CLP holders and drivers of CMVs for serious and major traffic offenses when it was warranted. Therefore, sanction actions against drivers have not occurred which is against state and federal laws. We are asking for your help in insuring that this does not continue. LEAs should issue UTCs when such violations occur. SAOs should either direct LEAs to issue UTCs or should issue UTCs themselves when the LEA does not. Convictions of 2 or 3 Serious Violations within a 3-year period will generate a sanction against the driver and convictions of a major violation will generate a sanction when our department receives the disposition information. Serious and major violations include but are not limited to:

Reckless Driving
Improper Lane Change
Following Too Closely
Driving a CMV without Proper Class of CDL or CDL Permit/Endorsement
Driving Under the Influence
Driving a CMV in Possession of a Controlled Substance
Using a Motor Vehicle in Connection with a Felony
Driving a CMV While the CDL is Suspended/Revoked/Cancelled or Disqualified

### **Reporting Convictions**

#### **Statutory Authority**

Within 10 days after final judicial disposition of each traffic violation, including parking on a roadway outside the limits of a municipality, or other offense reported on the uniform traffic citation, as prescribed by s. 316.650, the clerk of the court in which the case was tried shall report the judicial disposition of such case to the Department of Highway Safety and Motor Vehicles on a copy of the uniform traffic citation, which form shall be consistent with the Florida Traffic Court rules.

### **Reporting Convictions**

#### **Statutory Authority**

Requires the licensing entity of the State where the conviction occurs to notify the licensing entity in the State where the driver is licensed within <u>10</u> <u>days</u> of the conviction.

Requires the licensing entity of the State where the conviction occurs to report convictions to the Federal Convictions and Withdrawal Database within <u>10 days</u> of the conviction.

The State must not mask, defer imposition of judgment, or allow an individual to enter into a diversion program that would prevent a CLP or CDL holder's conviction for any violation, in any type of motor vehicle, of a State or local traffic control law (other than parking, vehicle weight, or vehicle defect violations) from appearing on the CDLIS driver record, whether the driver was convicted for an offense committed in the State where the driver is licensed or another State.

### **Convictions Defined**

#### **Statutory Authority**

An unvacated adjudication of guilt, or a determination that a person has violated or failed to comply with the law in a court of original jurisdiction or by an authorized administrative tribunal, an unvacated forfeiture of bail or collateral deposited to secure the person's appearance in court, a plea of guilty or nolo contendere accepted by the court, the payment of a fine or court cost, or violation of a condition of release without bail, regardless of whether or not the penalty is rebated, suspended, or probated.

### **Convictions Cont.**

Convictions in which the judge withheld adjudication will appear on the Florida Driver Record as:

\*ADJ WITHHELD BY JUDGE with CONV-FED Purposes Only"



### **School Election**

School election in §318.14(9) is not available to CLP, CDL holders or CMV operators.

➢ If the Department receives a school election the disposition will be changed to guilty and posted to the driver history and transcript accordingly.

>Also applies to wireless course.



### **Hardship Licenses**

#### **Statutory Authority**

A State may not issue a hardship license to operate a CMV when a CDL holder's CMV or non-CMV driving privilege has been suspended, revoked or cancelled.

>A State may not issue a hardship license to operate a CMV when the CDL holder's CMV driving privilege is disqualified.

### Emailing Court Assist



- Include the DL and citation number for the case number in question. If there's no DL number, include the name and date of birth, or social.
- Allow 3-5 business days for supplemental dispositions tied to a sanction sent via TCATS to update before emailing Court Assist.

#### Incompetent to Operate a Motor Vehicle

- Include the driver's full name, date of birth, last 4 digits of social and a DL number (if applicable). Also include if they were found "totally incompetent" or "limited".
  - If they are limited and their "rights to have a driver license" were NOT taken, DO NOT add to incompetent list.
  - Please attach court orders.

#### **Juvenile Orders**


- Include the driver's full name, date of birth, address, and gender for the driver record.
  - Please differentiate between the first and last name so an accurate record can be created.
- All orders need to indicate the revocation or suspension length recommended by the judge.




