		C03	If Citation is written, Officer Delivery Verification (ID 118) is mandatory for the officer and must be accurately indicated in the data file by COC.

Footnotes:

- 1. TCATS is the Traffic Citation Accounting and Transmission System used by the Florida Court Clerks & Comptrollers (FCCC) to receive electronically transmitted files from the county clerks. The system accepts eCitation data using an accepted Interface Control Document (ICD) for standard system data requirements that any case management system (CMS) vendor can use to improve the software provided to the clerks. The ICD uses ID's to identify and distinguish each field description and can be found at

- 2. The GROUP TITLE is the name given to a set of validations with the same ID's in the business rules or have ID's that are conditional to each other. The GROUPS have been numbered.
- 3. The Appendix C of the UTC Manual is the traffic infraction reference guide listing citable offenses, established under the authority of Section 316.650(1)(d), Florida Statutes. These violations are listed in order by Florida Statute number and contain information such as points, classification, and fine amounts.
