Only Florida Rider Training Program (FRTTP) recognized *RiderCoaches* may conduct Rider Courses in the State of Florida.

After reading, each line must be initialed.

Rules of conduct include, but are not limited to, the following:

- \_\_\_\_\_ 1. Conduct Rider Courses through an FRTTP approved school.
- \_\_\_\_\_ 2. Conduct Rider Courses that meet FRTTP Basic Rider Course (BRC), Basic Rider Course-2 (BRC-2) (experienced rider course) and Sidecar/Trike Course (S/TEP) requirements.
- \_\_\_\_\_ 3. Correctly demonstrate all range exercises.
- \_\_\_\_\_ 4. Correctly evaluate and coach student rider skills.
- \_\_\_\_\_ 5. Maintain student rider safety to the highest degree possible.
- \_\_\_\_\_ 6. Demonstrate safe riding habits by always wearing protective gear when riding to, from and during rider training activities (whether working or not). Ideally, all protective gear is worn at all times.
- \_\_\_\_\_ 7. Currently operate a motorcycle on a frequent and routine basis on public roadways.
- \_\_\_\_\_ 8. Ride free of alcohol and other drugs that cause impairments.
- \_\_\_\_\_ 9. Keep a good riding and driving record.

A good riding and driving record is defined as:

- No criminal offenses,
- No more than one non-criminal moving violation in any twelve month period, regardless of adjudication; and
- No cancellations, revocations, or suspensions of the driving privilege.

- \_\_\_\_\_ 10. Complete one *RiderCoach* professional development activity or any activity that requires the *RiderCoach* to be in a student or learning position, and one FRTTP update in a two-year period.
- \_\_\_\_\_ 11. Keep FRTTP informed of any personal information changes (e.g., change of address, name, etc.).
- \_\_\_\_\_ 12. FRTTP *RiderCoaches* may only teach Rider Courses for which BRC, BRC-2 and S/TEP requirements have been met.
- \_\_\_\_\_ 13. FRTTP *RiderCoaches* will conduct themselves in a professional manner that includes:
- Appearance
  - Appropriate language, exhibiting positive verbal and written messages
  - Positive interaction with others that is free from intimidation or threat, consistent with the best interest of FRTTP and its mission
- \_\_\_\_\_ 14. FRTTP *RiderCoach* recognition does not authorize a person:
- to make public statements on issues related to motorcycle safety on behalf of FRTTP,
  - to serve as an expert witness on motorcycle safety issues, or,
  - to address the public on matters outside curriculum presentation, primarily on the basis of FRTTP *RiderCoach* recognition and does not imply representation of FRTTP.
- \_\_\_\_\_ 15. FRTTP *RiderCoaches* are encouraged to support motorcycle safety programs and are not prohibited by FRTTP from speaking to the media, participating in a legislative or legal process, or expressing their opinions, as private citizens.
