# Motorist Modernization Advisory Board – Phase II Meeting Tuesday, February 13, 2024 2:30 to 4:00 PM VIA: Microsoft Teams

### WELCOME AND INTRODUCTIONS

• The meeting was called to order at 2:30 p.m. Kristin Green began the meeting by welcoming members and visitors and proceeded with the roll call of board members.

### **REVIEW OF MEETING MINUTES**

 Rachel Ramos reviewed the meeting minutes from December 12, 2023. No corrections were identified. A motion to approve the minutes was accepted by the board members and the December 12, 2023, meeting minutes were approved.

### PHASE II IV&V UPDATE

Alyene Calvo presented an overview of the IV&V report for Phase II. The current risk state was
amber and there was one open deficiency to report. Project risks are increasing due to
continued resource challenges with development and testing staff. Additional monitoring of
staffing capacity was put in place by FLHSMV. The agency hiring freeze remains in effect. The
project is currently tracking approximately 14.1 days behind schedule. The project is tracking
on budget. Change Requests continue to follow the established change management process.

### FINANCIAL REVIEW

• Judy Moats presented a Phase II financial review. The Phase II budget for the 2023 – 2024 fiscal year is approximately \$9.9 million. Approximately \$5.5 million was expended as of January 2024 with a less than 1% variance and approximately \$4.4 million in remaining funds. A Legislative Budget Request was submitted for the 2024 – 2025 fiscal year as well.





### PHASE II PROJECT UPDATE

- Joseph Weldon presented an overview of the ORION Releases:
  - Release 1 Motor Vehicle Issuance (MVI) Inquiry The pilot went live in October 2023 and then statewide on November 8, 2023.
    - MV Customer Inquiry, Customer Summary and linkage to DLI Customer Summary
  - Release 2 ORION Pilot Spring 2024
    - Pilot a subset of ORION transactions and Global Admin functionality to a select group of offices (TBD)
  - Release 3 International Fuel Tax Agreement (IFTA)/International Registration Plan (IRP) – June 2024
    - Celtic IFTA/IRP COTS Product and associated ORION updates
  - Release 4 ORION Statewide January June 2025
    - All core MVI and Global functionality
  - Release 5 Motor Vehicle MyDMV Portal Spring 2025
    - Motor vehicle functionality additions to MyDMV Portal
  - o Release 6 Batch, Back-Office June 2025
    - Remaining ORION back-office functionality and Phase II batch functionality
- Mr. Weldon then discussed the Release 2 schedule and the below list of Pilot sites.

- Mr. Weldon presented a status update for the Phase II project teams:
  - Titles & Registration (T&R) Team: The team was trending behind on development. They continued to focus on Release 2a readiness. Tax Collector offices in Hillsborough, Brevard, and Manatee Counties are fully engaged in testing and User Acceptance Testing (UAT). The team is also working on getting the training environment set up for the first set of Pilot offices. The team's user guides are currently in review by legal.
  - MV Globals Team: The team is trending behind on development. They continued to focus on setting up the training environment and 2a readiness. The team's user guides are also currently in review by legal.
  - O Portal/Fleet Team: The team is also trending behind on development. This is due to a lack of resources. Testing continued at a steady rate. They are on target for training and user guides as well.
  - <u>IFTA/IRP Team:</u> The team completed their production build and continued to work with the vendor on UAT. They are on target for training and user guides.
  - o Risks and issues impacting the teams included:





- Four Developer Vacancies Jobs have been posted.
- Open SEU Positions Jobs have been posted.
- National Motor Vehicle Title Information System (NMVTIS) Structured Testing – A risk was realized previously as there was a misalignment of FLHSMV's vision of the testing approach and AAMVA's vision.
- Mr. Weldon discussed the below critical path for Release 2:
  - Development
  - o UAT
  - Third Party Cashier Vendors
    - A meeting is scheduled for March 5, 2024, to discuss testing and provide the cashiering specs.
  - Security Testing
  - Performance Testing
    - Began dry-run last week.
  - Training
    - Vacancies have impacted the training group as well.
  - User Guides
- Release 2 ORION Pilot Critical Path for NMVTIS:

    - Initial Extract Brand & Title
    - Discrepancy Files from AAMVA
  - NMVTIS Web Service Integration Completed

  - The team met with AAMVA on January 22, 2024, to discuss changes to the structural testing approach. They decided to complete testing for FRVIS and EFS first and then move on to testing the ORION application.

### ORGANIZATIONAL CHANGE MANAGEMENT UPDATE

- Elise Batchelor stated in preparation and support for Release 2, the Organizational Change Management (OCM) team will continue to:
  - Hold Change Champion Network Connects with 72 Change Champions (Tax Collectors and their staff, and FLHSMV members);
  - Conduct Engagement meetings with key personnel from FLHSMV divisions and bureaus:
  - Conduct ORION demos with Change Champions and divisions/bureaus as needed;
  - Update the OCM SharePoint and PartnerNet pages with new tools/information;





- Submit articles to newsletters such as the NewsWheel and ORION Hub;
- Send updates to the Change Champions via the OCM email;
- Assist with Phase II Tax Collector testing (Brevard, Hillsborough, Manatee).
- Facilitate discussions related to Phase II Pilot and Go-Live inventory strategy;
- Conduct a Pilot Assessment with each of the Pilot offices as they onboard;
- Assist the OMM Communications Consultant with the Phase II communications plan.


