#### WELCOME AND INTRODUCTIONS

• The meeting was called to order at 2:30 p.m. Terrence Samuel began the meeting by welcoming members and visitors and proceeded with the roll call of board members.

#### **REVIEW OF MEETING MINUTES**

• Rachel Ramos reviewed the meeting minutes from January 10, 2023. No corrections were identified. A motion to approve the minutes was accepted by the board members and the January 10, 2023, meeting minutes were approved.

#### PHASE II IV&V UPDATE

Margie France presented an overview of the IV&V report for Phase II. The current risk state
was green. There were no open deficiencies to report. The schedule performance index was
0.993. 17 of 1,748 total tasks contained in the project schedule were late. The program
completion date was forecasted to be 13.5 days late. They are evaluating the approved
December 2022 Change Request for its impact to the project schedule.

#### FINANCIAL REVIEW

• There was no financial review at the meeting.

#### PHASE II PROJECT UPDATE

• Joseph Weldon discussed Phase II issues impacting the program. These included:

- Issue 15 Developer Vacancies The team has a total of three vacancies.
- Issue 20 Phase II Development and Testing The team is trending behind on multiple milestones.
- Issue 35 Not Sufficient Backlog for Sprint Planning The team continues to work on completing two sprints worth of stories refined prior to sprint planning.
- He mentioned there are also late training tasks related to training material development for MyDMV Portal and Title and Registration. The Learning and Development Office has begun training material preparation using the Stage environment.
- Mr. Weldon stated for Team A (Title and Registration) SEU continued to test 17 remaining Milestone I stories. The team is trending behind on refinement, development, and testing for Milestone J. The team has one story remaining to refine and seven stories left to develop for Milestone K. There are 106 stories remaining for refinement, 162 for development, and 224 to test for Milestone L. The team just began refinement for Milestone M. The team completed Sprint 49 today with a demo and retro. The focus for the team continued to be development of the change requests for NMVTIS for Milestone J, and development for personalized plate, specialty plate voucher, and express renewal for Milestone L.
- Mr. Weldon stated Team B (MV Globals) continued to work on completing Milestone K with one story remaining to develop and test. The team has 45 stories to refine, 47 to develop, and 61 to test for Milestone L. The team began refinement for Milestone M. The team is working in Sprint 49 with a demo and retro scheduled for tomorrow, February 15. The team continued to focus on the motor vehicle history inquiry screens for Milestone K, the motor vehicle records request for Milestone M, and refining fleet maintenance and the stop queue.
- Scott Tomaszewski stated for the IFTA/IRP team, Milestone N is scheduled to be complete in April 2023. The focus is on technical work supporting global changes needed by Phase II applications with the highest priority being addressing interface bugs reported by the vendor. The vendor is tracking to complete all their configuration changes when the audit module is completed April 21, 2023. The development stoplight is yellow. Developers will carry over the research work needed to complete designs of the refund process, confirming the legacy processes that will still function after go-live. Currently, the vendor has three registered urgent bugs being worked, and eight resolved urgent bugs being validated. The testing stoplight is red as IRP Distribution End-to-End functional testing will carry over four blocked testing stories into the next sprint, all of which are related to data that meets the test scenario requirements.
  - Key dependencies for the team included:
    - Last meeting, we were tracking a vendor request test in the Stage environment as the data is newer (around 2019) from the last production pull.
    - The vendor is currently working to complete their data conversion upload to the Stage environment and to complete their environment confirmation.
  - Key risks and issues for the team included:
    - Issue 75 IFTA Distribution Process The end of day report issues was
      resolved and tested by accounting allowing Change Request 25 to be marked
      complete on January 9, 2023. This issue is considered closed.
  - Important activities for the team included:
    - Initiate Vendor Transactions end-to-end testing in the Stage environment.
    - Provide support for vendor configuration through April 2023.
- Mr. Weldon stated for the Florida Smart ID (FSID) team, the amendment was signed by Thales and Change Request 32 was completed. This updated the FSID Phase 3 schedule. The team is preparing for Release 3 in May 2023.





- Important activities for the team included:
  - Amendment 2/Change Request 32 FSID Phase 3 Amendment 2 Changes
  - Release 3 May 2023
    - Registration/Insurance (House Bill 0749)
    - Online Authentication (MyDMV Portal to integrate with AHCA)
      - High-Level Schedule:
        - Requirements Approved January 2023
        - Development Complete March 2023
        - UAT Complete April 2023
        - Production Demo May 2023
- Key dependencies for the team included:
  - Keep initial release meaningful but sized for "success" given short timeline.
  - Other vendors are dependent upon Thales Remote Enrollment updates.
- Risks and issues for the team included:
  - Issue 42 Risk 94 Realized FSID Onboarding Trending Late
  - Issue 62 FSID Phase 3 Delayed Start This will be closed as the contract is now signed.
- Michael Anderson stated the Enterprise Content Management (ECM) team closed Risk 122 regarding availability of the long-term storage. The production conversion is trending behind schedule due to delays in completing the sample conversion. The team is evaluating ways to increase the production conversion velocity.
  - Important activities for the team included:
    - Finalizing conversion verification for final document type (MVVI)
    - Production configuration updates completed on February 2, 2023 (delayed due to State-to-State deployment/Go-Live)
    - NPS provided long-term storage January 17 and team started pre-staging images for the production conversion (most time intensive part of the conversion process)
      - Evaluating metrics to see if velocity can be increased
    - Planning effort for DLSCAN conversion on hold while we focus on production conversion efforts
  - Key dependencies for the team included:
    - Production conversion dependent on completion of successful sample conversion
    - Availability of Conversion Hardware to begin production conversion
    - Risks and issues for the team included:
      - Risk 101 Delays in configuring new documents in OnBase could cause schedule delays.
      - Risk 122 If long term storage is not procured, the ECM schedule could experience further delays. This was closed on January 17, 2023.
- Aundrea Powell stated the MyDMV Portal/Fleet team is currently working in Milestone L, Sprint 44. They are working on the approved Change Request 31 for Milestone L stories including Parking Permits (Renewals, Replacements, Subsequent), as well as developing Registration Renewal. The development team continued to support any bug fixes for Change Request 31.
  - Important activities for the team included:

- Continuing design questions for Kiosk, inventory control, printing, and in-office pick-up for issuances in Portal team backlog
- Designing FSID Authentication and insurance clearance via Portal
- Key dependencies for the team included:
  - There are dependencies on the approval and prioritization of new features and any features that can be deployed earlier than the approved release schedule.
  - There are cross-team dependencies on readiness of the code from Teams A and B.
- Risks and issues for the team included:
  - Issue 15 Two developer vacancies currently
  - Issue 70 Cross-team dependency upgraded to an issue. The team is currently impacted by core requirements and coding.

#### **COMMUNICATIONS UPDATE**

• Ann Naiman stated the Policy and Procedure User Guide working groups have received the next set of assignments and continued to make progress. The team is working on a dashboard to display the progress of the working groups at future meetings.

#### **ORGANIZATIONAL CHANGE MANAGEMENT UPDATE**

 Elise Batchelor stated the Organizational Change Management team held their Change Champion Kick-Off on February 8 – 9, 2023, with more than 60 Change Champions in attendance. The team presented an overview of Motorist Modernization, updates on ORION, MyDMV Portal, and FSID, and training.








## **Phase II Expenditures by Month**






