### **REVIEW OF MEETING MINUTES**

• Rachel Ramos reviewed the meeting minutes from June 13, 2023. No corrections were identified. A motion to approve the minutes was accepted by the board members and the June 13, 2023, meeting minutes were approved.

### PHASE II IV&V UPDATE

Alyene Calvo presented an overview of the IV&V report for Phase II. The current risk state was
green and there were no open deficiencies to report. The project is currently tracking
approximately 10 days behind schedule. The project is currently tracking on budget. Change
Requests continue to follow the established change management process. Project risks are
holding steady. Turnover and retention challenges for development staff continue to be
experienced. Additional monitoring of staffing capacity has been put into place by FLHSMV.





### FINANCIAL REVIEW

Judy Moats presented a Phase II financial review. The Phase II budget for the 2022 – 2023 fiscal year is approximately \$9.9 million. Approximately \$9.9 million was expended as of June 2023 with a less than 1% variance and approximately \$89 in remaining funds. The Legislative Budget Request has been submitted for fiscal year 2024 – 2025 as well.

### PHASE II PROJECT UPDATE

- Joseph Weldon discussed Phase II issues impacting the program. These included:
  - Issue 15 Developer Vacancies The team has a total of four vacancies.
  - Issue 20 Phase II Development and Testing Late The team is trending behind on some milestones and tasks related to Florida Smart ID (FSID).
- Mr. Weldon stated Team A (Title and Registration) is currently focusing on closing 18 development stories for Milestone N. The team is trending behind on completing Milestone O as well.
- Mr. Weldon stated Team B (MV Globals) was working in Milestone O, Sprint 55. The team is trending behind on completing Milestones N and O.
- Scott Tomaszewski stated the IFTA/IRP team continued to work in Milestone O. They wrapped up development support for Sprint 9. They were working on urgent interface bugs, completing a production change to use field credit card service in the IFTA/IRP walk-in counter location (which will require a change request to the vendor's solution to make ready for go-live), and Senate Bill 1582 to accommodate 3-year apported plates instead of 1-year. They start Sprint 10 tomorrow, July 12, 2023. Performance Testing and System Integration Testing is pending the setup of proper test data across 2020, 2021, 2022, and 2023. Business Analysts and technical staff provided IFTA and IRP inventory for these four years. The team created the inventory in the current date and postdated them so they could align with the four-year period. Testers are waiting for additional stories to be marked "refinement complete" from the vendor release 2.5.4. The team has 13 urgent bugs they had challenges in mitigating as they were faced with errors in both the Test and Stage environments pulling already limited resources away to resolve.
  - Deliverables for the team included:
    - Deliverable 38 Celtic Motor Services SCHEMA Layout Review cycle 1 was completed on July 7, 2023, and feedback provided to the vendor. The team is waiting on their response to close out the review.
    - Deliverable 21 UAT Completion Report Targeted for October 23, 2023.
  - Key dependencies for the team included:
    - Stage data being correct to run end-to-end transactions.
    - Stage environment not changing during Performance and System Integration Testing.
  - Key risks and issues for the team included:
    - Risk 129 After hours support for IFTA/IRP vendor was registered on March 2, 2023, and is being monitored.
  - Important activities for the team included:
    - Plan/Conduct Performance Testing and System Integration testing not hindered by stage environment changes.
    - Continue providing support for vendor requested urgent interface bug fixes.

- Mr. Weldon stated the FSID team had their production release for Release 3. This included registration/insurance and online authentication for MyDMV Portal. The team met with TSA to discuss certification. A meeting is scheduled with Google later this month as well.
  - $\circ$   $\;$  Important activities for the team included:
    - Release 3 June 2023
      - Registration/Insurance (HB 0749)
      - Online Authentication
    - TSA Certification June 29
    - Meeting with Google July 2023
  - Key dependencies for the team included:
    - Keep initial release meaningful but sized for "success" given short timeline.
    - Other vendors are dependent upon Thales Remote Enrollment updates.
  - Risks and issues for the team included:
    - Issue 42 Risk 94 Realized FSID Onboarding Trending Late
- Michael Anderson stated the Enterprise Content Management (ECM) team is trending behind schedule. However, the team and vendor continue to monitor the production conversion and make progress. The team is investigating an issue with the sample conversion experiencing a lower velocity.
  - Important activities for the team included:
    - Continuing MVSCAN production conversion
    - Investigating low than expected conversion rate
    - Finalizing details with scanning unit vendor to update scanner output files for OnBase intake
    - Legacy System teams working integration with the Content Service into schedule
    - Draft DLSCAN conversion schedule complete, waiting on MVSCAN conversion to near completion prior to finalizing
  - Key dependencies for the team included:
    - HSMV scanning unit software requires update to output file format for ingesting into OnBase prior to Go-Live
    - FRVIS will need to integrate with the Content Service prior to Go-Live
  - Risks and issues for the team included:
    - Risk 101 Delays in configuring new documents in OnBase could cause schedule delays.
- Aundrea Powell stated the MyDMV Portal/Fleet team is currently working in Milestone O, Sprint 50. They were also working on testing and developing Registrations Renewals and upload, and Plate Replacements for Milestone N. The team has refined MV express and are preparing for fleet management.
  - Important activities for the team included:
    - Continuing design for convenience issuances inventory control and printing
    - MV Check to Production TBD
    - Turn-Off Socure Authentication Out of Production TBD
  - Key dependencies for the team included:
    - There are dependencies on the approval and prioritization of new features and any features that can be deployed earlier than the approved release schedule.





- There are cross-team dependencies on readiness of the code from Teams A and B.
- Risks and issues for the team included:
  - Issue 15 Two developer vacancies currently open.
  - Issue 133 Socure and production moves added scope to backlog; therefore, pausing the Milestone planned scope.
- Ann Naiman stated the primary focus for the Policies and Procedures Manual and User Guides team is the draft manual for Titles & Registrations and Globals (Release 1). The first draft was submitted and is currently being reviewed for ADA compliance.

      - Draft Due: 07/25/23
      - Review Due: 09/14/23
      - MV Procedures, Titles & Registration, MV Globals (Release 2)

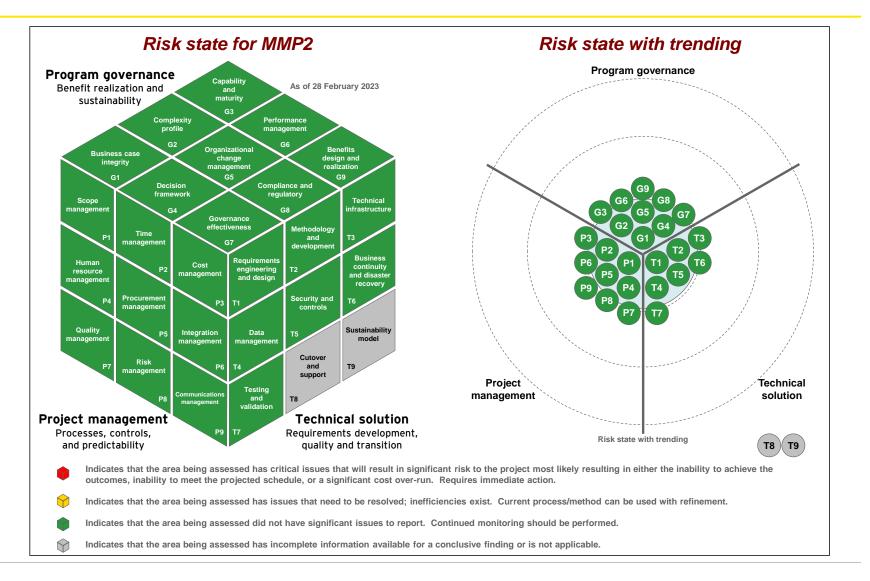


