While conducting my duties, as a State Trooper with the Florida Highway Patrol in Osceola County, I was stationary at the MM192 center median observing northbound traffic. I observed a white 4D sedan) driving recklessly and improperly changing lanes around a white pickup truck. Both (FL Tag# vehicles passed me and I observed the white 4D sedan through my left rear-view mirror as it was traveling in and out of lanes through traffic. As I made my way into the northbound traffic, I continued to observe the white 4D sedan following vehicles too closely, improperly changing lanes cutting in front of vehicles, and traveling at high rate of speed over the posted speed limit passing traffic. I immediately proceeded to intercept the vehicle. I notified our Lake Worth Regional Communication Center of the situation and provided information for a BOLO (Be On the Look Out). As I continued northbound on SR-91 (Florida Turnpike), I observed the vehicle continue to travel recklessly around traffic, improperly change lanes, follow too closely, and pull away from traffic at high rates of speed over 100mph. Upon catching up to the vehicle, around SR-91 (Florida Turnpike) MM203, I observed the vehicle traveling in traffic unable to go around. I notified the nearest unit Tpr. Mas #1412, to standby to conduct a traffic stop on the vehicle. When safe to do so, I activated my emergency equipment, overtook the vehicle, and conducted a traffic stop. The vehicle slowly pulled over on the right shoulder of SR-91 (Florida Turnpike) around northbound MM203.5. The occupants were given a lawful command to exit the vehicle, which both occupants complied and exited as instructed. The driver of the vehicle was later identified as Zion Zaire Vincent Waller DOB: (FL DL#:), and was immediately placed under arrest for Reckless Driving and placed in my marked patrol vehicle. The passenger, Mi'AJhai Rene Cleaves, was detained and placed in Tpr. Mas marked patrol vehicle. Tpr. Mas inventoried the vehicle for the tow incident to arrest, at which point he found in plain view, a rifle (Premier Firearms 556), and a hand gun (Glock 45) both loaded, in the front side floorboard. We asked both parties what occurred. At which point a white pickup truck pulled up alongside us and advised their vehicle had been shot. I advised the driver of the pickup truck (FL tag#:) to pull up ahead of our marked patrol vehicles. I walked up to the vehicle and the driver, later identified by his Driver License as , advised his vehicle was shot at by the driver of the vehicle we had stopped. pointed at a bullet hole on his driver / left side of his vehicle, between the

driver side door and the passenger door (B-pillar). The vehicle had a total of three occupants. also advised the white 4D was driving erratically around his vehicle prior to being shot at.

I spoke to Mr. Waller, defendant and the driver of the white 4D sedan, he advised me that he was involved in a road rage incident with the white pickup truck several miles south of our location. Mr. Waller advised that the pickup truck was driving erratically around his vehicle, and at one point the driver pointed at him with what appeared to be a weapon. Mr. Waller advised he feared for his life and shot one round at the white pickup truck and sped up trying to stay away. Mr. Waller made the statements pre and post Miranda rights read to him. Mr. Waller was asked why he did not pull over and call 911 and Mr. Waller advised he did not feel safe pulling over. The passenger Mrs. Cleaves confirmed, that Mr. Waller did shoot at the white pickup truck, attempting to shoot at the tires. With the statement made by Mr. Waller, and the consent of statement. After a search of the interior of the vehicle for a weapon to confirm Mr. Waller's statement of a weapon. Statements were obtained from the passenger of the suspect vehicle, and of the driver from victim vehicle.

Mr. Waller does not hold a concealed weapon permit in the State Florida. Mr. Waller was transported to the Osceola county jail, without further incident. Our Bureau of Criminal Investigations and Intelligence was contacted and responded to the scene took pictures of the vehicles and will be assisting with the processing of the vehicles and further investigation if necessary. Tpr Baez Diaz#1272 transported the weapons and submitted into the Troop K evidence section. Tpr. Mas submitted the vehicles into the Troop D evidence section. No parties reported any injuries. All charges listed on the generated incident report. All events occurred in Osceola County.

On Monday April 17, 2023 approximately 8:59pm, I spoke to a witness that confirmed the white 4D sedan's reckless driving prior to the traffic stop leading to arrest.

Charges:

- Three counts of attempted murder
- Aggravated Battery with a deadly weapon
- Shooting into or throwing deadly missiles into a vehicle
- Unlicensed Firearm
- Reckless Driving
