Legal Authority

[Section 320.131](#), Florida Statutes, authorizes the issuance of temporary tags, which may be issued for a period of 10, 30, or 90 days according to the purpose for which the license plate is issued.

[Section 320.131\(3\)](#), Florida Statutes, provides that any person or corporation who unlawfully issues or uses a temporary tag or violates this section or any rule adopted by the department to implement this section, commits a noncriminal infraction, punishable as a moving violation as provided in chapter 318 in addition to other administrative action by the department. Using a temporary tag that has been expired for a period of 7 days or less is a noncriminal infraction and is a nonmoving violation punishable as provided for in chapter 318, Florida Statutes.

[Section 320.131\(6\)](#) , Florida Statutes, any person who knowingly and willfully issues a temporary tag or causes another to issue a temporary tag to a fictitious persons or entity to avoid disclosure of the true owner of a vehicle commits a felony of the third degree.

[Section 320.131\(9\)\(a\)](#), Florida Statues, authorizes a secure print-on-demand electronic temporary tags registration, record retention, and issue system for use by every department-authorized issuer of temporary tags.

[Section 320.131\(9\)\(b\)](#), Florida Statutes, allows for the issuance of a backup manual issuance method during an outage.

Description And Use

This procedure provides information and instructions to assist the Tax Collector Employees, License Plate Agents, Dealers and the Florida Department of Highway Safety and Motor Vehicles (FLHSMV) with the issuance of temporary tags.

As of July 01, 2023, FLHSMV has updated the Form HSMV 82040 Application for Certificate of Title With/Without Registration. HSMV 82040 has been updated into three separate forms:

- HSMV 82040 MV – Application for Certificate of Motor Vehicle Title - [HSMV 82040 MV](#)

HSMV 82040 MV should be used when processing applications for certificate of title for the following vehicle types:

- AU – Auto
- BS – Bus
- MC – Motorcycle
- OH – Off-Highway
- TO – Tools
- TR – Truck
- TT – Travel Trailers
- VT – Vehicle Trailers

- HSMV 82040 VS – Application for Certificate of Vessel Title – [HSMV 82040 VS](#)

HSMV 82040 VS should be used when processing applications for certificate of title for the following vehicle type: VS – Vessel

- HSMV 82040 MH – Application for Certificate of Mobile Home – [HSMV 82040 MH](#)

HSMV 82040 MH should be used when processing applications for certificate of title for the following vehicle type: MH – Mobile Home

Effective July 01, 2023, all certificate of Florida titles issued for Vessels will be required to be processed using Form HSMV 82040 VS – Application for Certificate of Vessel Title. The signed Form HSMV 82041 will no longer be accepted in lieu of Form HSMV 82040 VS.

FLHSMV anticipates accepting the current HSMV 82040 – Application for Certificate of Title With/Without Registration for Motor Vehicles and Mobile Homes until December 31, 2023.

Effective January 01, 2024, all certificate of Florida titles issued for Motor Vehicles and Mobile Homes will be required to be processed using Forms HSMV 82040 MV – Application for Certificate of Motor Vehicle Title and HSMV 82040 MH – Application for Certificate of Mobile Home Title.

Issuance of a Temporary License Plate for use on a Motor Vehicle, Motorcycle, or Recreational Vehicle

When issuing a temporary tag, the issuing authority must ensure the accuracy and accountability of the license plate. A temporary tag may only be issued and displayed on one vehicle. Re-issuance of the same temporary tag is not lawful.

The Division of Motorist Services Regional office or Tax Collector office have the discretionary authority to issue more than two temporary tags.

A. Issuance of a Temporary Tag to an Applicant:

1. The Electronic Temporary Registration (ETR) System is a method to electronically submit information regarding the issuance of a temporary license plate.
 - a. All temporary tags must be issued as print-on-demand, except in the case of an ETR system outage or a trailer with a net weight of less than 2,000 lbs. See procedure RS-05, section II-C, for exemptions to print-on-demand.
 - b. A dealer is authorized to issue only two temporary tags for a specific motor vehicle, motorcycle, or recreational vehicle per customer. For example, Jane Doe buys a car and needs a temporary license plate, then later needs a second temporary license plate. After the second issuance, no more temporary tags can be issued to Jane Doe for that vehicle.
 - c. A dealer can issue a maximum of four temporary tags per motor vehicle, motorcycle or recreational vehicle when dealing with multiple customers. For example, John Smith buys the same car that Jane Doe did – the dealership can issue two temporary tags to him for the same vehicle.
 - d. When use of a dealer license plate is valid, a temporary tag may not be issued.
 - e. An exception is when the dealer is complying with section 320.131(1), Florida Statutes.
2. If the dealer chooses not to issue temporary tags through an ETR vendor, the dealer must submit all applications to a county tax collector or license plate agent for processing. The following documentation is required:
 - a. Form HSMV 83091, Application for Temporary License Plate, (including the purpose for issuance) signed by an authorized representative for the issuing agency/dealership (if applicable) and the customer. A copy of the title or MCO must be submitted to verify the VIN is correct.

HSMV 83091 is distributed as follows:

 - The customer retains the original copy, which must always be in the operator's possession while the motor vehicle, motorcycle or recreation vehicle is being operated with the temporary tag (until expiration).

- The issuing agency (tax collector or license plate agent) retains the duplicate copy for at least 12 months.
- b. Proof of identity as required by procedure TL-01, Signature Requirements. Proof of identity cannot be an expired driver's license, identification card or passport. All documents must be current and valid. If the company is a business, it must provide an FEID number if applicable, verification that the business is authorized to conduct business in Florida, or a Florida city/county business license or number. As indicated in TL-01, do not create a new customer record when the customer already exists in FRVIS.
 - c. Proof of insurance except for motorcycle, trailers, and federally owned vehicles. Refer to procedure RS-36 for additional insurance requirements.
3. If the temporary tag is being issued for a vehicle that will be registered in another state, proof of issuance from that state is required.
For an out of state insurance:
Enter Code "S" for the insurance type and "out-of-state" in the "Policy Number" field. The out-of-state insurance company name, policy number, effective date and insurance company's phone number must be entered in the FRVIS comments field.
Example: State Farm, 00123456, 02/01/18, 1-800-111-1111
 4. A fee of \$2 must be collected for each temporary tag issued. A Service Fee (and Branch Fee, if applicable) may be collected if a county tax collector, license plate agent, Division of Motorist Services Regional Office, or Direct Mail and Corrections Section issues the temporary license plate.
 5. A temporary tag shall not be issued for a specific motor vehicle, if the owner of that vehicle has filed or intends to file a non-use and other certifications. Please see form HSMV 82040 (number 11).
 6. If the temporary tag is issued by a dealer through ETR, the dealer must remit the \$2 temporary tag fee to FLHSMV through the dealer's ETR provider. A dealer may disclose the \$2 temporary license plate fee as a state mandated fee; however, any fee collected above that amount may not be identified as a state-assessed fee and must be disclosed in a clear and conspicuous manner in the sales agreement.
- B. Use of a Temporary Tag:
1. The county tax collector or license plate agent may issue a temporary tag for a period of 10, 30, or 90 days including the date of issue, based on the use of the temporary tag. Dealer may only issue temporary tags for a 30-day period. After the 30-day period expires, dealers may issue one additional 30-day temporary tag.
Pre-printed temporary tags may only be issued to trailers under 2,000 pounds or in case of an ETR outage. See section II-C.

- a. Ten (10) day temporary tags may be issued under the following circumstances:
 - When a motor vehicle is required to be weighed for registration purposes
 - When a motor vehicle/motorcycle is required to have the vehicle identification number verified or the motor vehicle/motorcycle must be inspected to apply for a Florida Certificate of Title or for registration purposes
 - When a customer schedules a vehicle for a rebuilt inspection at a Regional Office or an authorized Private Rebuilt Vehicle Inspection facility (PRVIP) within 10 days of the issuance of the temporary license plate.
2. Thirty (30) day temporary tags may be issued under the following circumstances
 - a. A “casual or private sale” means any sale other than that made by a licensed dealer, such as:
 - 1.) For demonstration purposes by the seller. A temporary tag cannot be issued for demonstration purposes if the current vehicle owner has not previously registered the vehicle. A temporary tag cannot be issued in lieu of renewal of the license plate currently assigned to the vehicle.
 - 2.) When the purchaser of a motor vehicle/motorcycle is waiting for the Florida Certificate of Title to be released by the previous owner’s lienholder. The following must be presented to the tax collector or license plate agent for them to “mark the title as sold” and issue a temporary tag, since the lien is not being satisfied now:

A letter of verification (signed by the previous owner’s lienholder) stating the loan has been paid and it will be several weeks before the title (with the lien satisfaction) is mailed to the customer

Or,

A letter of verification (signed by the purchaser’s lienholder) stating they have paid off the loan (against the previous owner) and it will be several weeks before the previous owner’s lienholder releases the title (with the lien satisfaction) to them from the customer.

And,

Form HSMV 82050, Notice of Sale or Transfer of Motor Vehicle, Mobile Home, Off-Highway Vehicle or Vessel.
 - b. For certified common carriers or drive-away companies who transport motor vehicles, motorcycles, mobile homes, or recreational vehicles from one place to another for persons other than themselves.

- c. For bank, credit unions, and other financial institutions which are not required to be licensed under the provisions of section 320.27, 320.77, or 320.771, Florida Statutes, but need temporary tags to demonstrate repossessions for sale.
 - d. When a motor vehicle, motorcycle or recreational vehicle is sold in this state to a resident of another state for registration in their home state and is not required to be registered under the provisions of section 320.38, Florida Statutes. Refer to TL-08 for required sales tax information.
 - e. When an out-of-state resident, subject to registration in this state, must secure ownership documentation from their home state.
Example: an individual from another state is moving to Florida and needs to get their title documentation from the other state or register and title their vehicle in Florida.
 - f. For a rental car company, which possesses a motor vehicle dealer license and uses temporary tags on vehicles offered for lease by such company. However, the original issuance date of a temporary tag shall be the date that determines the applicable license plate fee. (The date the license plate is issued is the date used to determine fees due).
 - g. For a marine boat trailer dealer to issue upon the sale of a marine boat trailer.
 - h. For use to transport a motor vehicle, motorcycle, or recreational vehicle in the dealer's inventory to and from the dealer's licensed location to an off-premises sales location and back. A dealer will only be able to get if they do not have an active dealer tag.
 - i. For use on a commercial vehicle (heavy truck), even carrying a load, if the vehicle remains in Florida, proof of HVUT is required, unless purchased in the first 60 days. If the commercial vehicle is traveling out of state, a trip permit for IRP and IFTA is required.
3. A ninety (90) day temporary tag may be issued to a customer upon application for a personalized or special license plate, while the license plate is being manufactured (see RS-27).
- C. System Outage Information for ETR Participants (Dealers):
- An ETR dealer may issue a pre-printed temporary tag only in the case of an ETR outage. In addition to section II-A, the following requirements must be met when a pre-printed temporary tag is issued due to an ETR System outage:
- a. Complete form HSMV 82082, Off-Line Issuance of a Pre-Printed temporary tag, in full and retain the dealer records for a period of 5 years.

- b. The issuance information must be reported to FLHSMV within one business day (excluding weekends and holidays) of the issuance of the temporary tag.
 - c. Refer to procedure RS-05 for more information about electronic temporary transfers and system outages.
- D. Entities Issuing Pre-Printed Temporary Tag for Trailers Weighing less than 2,000 Pounds: When a temporary tag is issued to a customer, the entity will need to provide form HSMV 82082 to the tax collector or license plate agency. The entity should keep a copy of form HSMV 82082 for its records.

Ordering Pre-Printed Temporary Tags

- A. Tax collector or license plate agencies are required to supply pre-printed temporary license plate to dealers for use when there is an ETR outage or for anyone issuing temporary tag to trailers weighing less than 2,000 pounds.
- B. FRVIS has a limitation of issuing a maximum of 25 pre-printed temporary tags per transaction. This limitation was only so that FRVIS could calculate the appropriate mail fees. This is not a limitation on the number of pre-printed temporary tags that can be issued to a dealer. Upon a dealer requesting to purchase pre-printed temporary tags, the issuing agency shall verify the “Dealer Inquiry” screen in FRVIS to ensure the dealer’s temporary tag privileges have not been suspended. If the dealer’s temporary tag privileges have been suspended, the sale of pre-printed temporary tags is not authorized, and the dealer shall be referred to a Bureau of Dealer Services (BDS) Regional Office.

Form HSMV 83090, Application by Florida Motor Vehicle, Motorcycle, Mobile Home or Recreational Vehicle Dealer for Temporary tags must be completed and submitted by the dealer to a county tax collector, license plate agent, or a Division of Motorist Services Regional Office. When HSMV 83090 is submitted by a dealer to a county tax collector office or license plate agent, a copy of the completed form must be mailed or scanned and electronically transmitted within two (2) business days to the Division of Motorist Services Regional Office that serves the issuing county. This will ensure that dealers have the required ETR/EFS vendor and enable regional offices to ensure that temporary tags are being used appropriately. The regional office that will retain the copy locally for 12 months in a dealer file for that office.

A fee of \$2 is required for each temporary tag issued. A Service Fee (and Branch Fee, if applicable) may be collected if a tax collector, license plate agent, Division of Motorist Services Regional Office or Direct Mail Section issues the temporary tags. Refer to the Registration Fee and Flat Tax Distribution Chart for applicable fees.

If applying for a pre-printed temporary tag by mail, the following mail fees are required for these increments:

Number of Temporary License Plates	Mail Fee
05	\$4.90
10	\$5.45
25	\$7.50

Display

All temporary tags must be conspicuously displayed in the rear license plate bracket. On vehicles requiring front display of license plates, temporary tags must be displayed on the front of the vehicle in the location where the metal license plate would normally be displayed.

Sales Tax Requirements

When a motor vehicle, motorcycle, or recreational vehicle is sold in this state to a resident of another state for registration, issuance of Florida temporary tag requires payment of sales tax to Florida as follows:

When the motor vehicle, motorcycle, or recreational vehicle is purchased from a Florida licensed motor vehicle dealer or in a “casual sale,” sales tax is required equal to but not more than the rate of sales tax levied by the purchaser’s state of residence. Complete Form DR123 Partial Exemption for Motor Vehicle Sold to Resident of Another State.

The county discretionary surtax is not applicable to out-of-state residents.

See procedure TL-08 for further clarification.

Miscellaneous

- A. When the title record indicates “EFS Pending,” no ETR transactions should be allowed. The dealer that has the pending Electronic Filing System (EFS) transaction should complete or void the EFS registration and title transactions. At no time should an EFS dealer issue an ETR (to the same purchaser) after the EFS transaction has been completed. At no time should a dealer issue a temporary tag once FLHSMV has issued a registration.

- B. Motorcycle sized temporary tags should only be issued to motorcycles, motorcycle trailers and any trailer under 2,000 pounds.
- C. Most occurrences of multiple records with the same VIN may now be processed through the ETR System by the vendor and are not required to be submitted to a county tax collector's office or license plate agent for processing.
- D. The dealer must issue a temporary tag or visit the tax collector's or license plate agent's office to purchase the metal plate if the customer does not have a metal license plate to transfer.
- E. The use of a temporary tag in no way constitutes payment of registration tax. When the motor vehicle is registered in the state of Florida, tax is due from the date of sale or transfer.

Exhibit A

1. Can a temporary tag be issued to a Florida resident who has just purchased a vehicle in the state and needs to drive the vehicle to a port to be shipped out of the country?
Yes, if the customer submits an application for a transfer of title into their name and is paying the applicable sales tax. However, only ONE ten (10) day temporary tag may be issued for this purpose.
2. Does question #1 also apply to a vehicle purchased from a dealer?
Yes. However, the dealer must go to a license plate agent for them to process the temporary tag for the customer, since a dealer cannot issue a 10-day temporary tag.
3. Can a temporary tag be issued to an out-of-state resident who has just purchased a vehicle in Florida and needs to drive the vehicle to a port to be shipped out of the country?
Yes, if the customer is paying the applicable sales tax. However, only ONE ten (10) day temporary tag may be issued for this purpose.
4. Does the license plate agent need any type of proof that a vehicle is being shipped out of the country (see question #1 and #2)?
No. However, only ONE ten (10) day temporary tag may be issued for this purpose. When completed form HSMV 83091, the “other purposes” box must be marked and the explanation of “the vehicle is being shipped out of the country” must be stated.
5. Can a 10-day temporary tag be issued if the customer previously applied for a title only transfer using a non-use affidavit and now wants to get a temporary tag to drive the vehicle to a port for shipping out of the country?
6. Can a 10-day temporary tag be issued if the customer previously applied for a title, purchased a license plate which has now expired, and wants to get a temporary tag to drive the vehicle to a port for shipping out of country?
No. The temporary tag may only be issued at the time of the title transfer. Therefore, the customer would have to renew their expired registration to drive the vehicle to the port.
7. Can a temporary tag be issued to an out-of-state resident who purchases a vehicle in Florida from an individual (casual sale) with an out-of-state title and wants to drive the vehicle back to their state of residence?
No. The customer must consider other means to get the vehicle back to their state of residence (i.e., get a temporary tag from their state of residence, trailer the vehicle back to their state, etc.).

8. Can a temporary tag be issued to an out-of-state resident who purchases a vehicle in Florida from an individual (casual sale) with a Florida title, and wants to drive the vehicle back to their state of residence?

Yes, if the customer is paying the applicable sales tax.

9. RS-31 states if a dealer chooses not to issue a temporary tag through an ETR vendor, the dealer must submit all applications to a county tax collector or license plate agent for processing. Is the license plate agent supposed to issue one of the dealer's temporary tag through the Registration-Original-Dealer ETR transaction so the system will show the dealer info, or is it to process an original registration, issue one of our print-on-demand or regular temporary tag and put the dealer's name in the comment field?

There are two scenarios:

For dealerships without a vendor, the agency must use only the Registration-Original-Dealer ETR transaction. Since the dealership does not have a vendor, it should not have any pre-printed temporary tag in its possession. Also, a Registration-Original-Regular must never be used.

For dealerships with a vendor, the agency may issue either a print-on-demand or a pre-printed temporary tag from the dealership's inventory.

The only time you may use a Registration-Original-Regular for a dealership with a vendor is when a third temporary tag has been approved and is required. You would then enter the reason for the third temporary tag and the dealer license number
