



2019 Private Rebuilt Motor Vehicle Inspection Training and Curriculum Requirements

Initial (24) Hour Rebuilt Vehicle Inspection Training

Any person (student) interested in becoming an authorized Private Rebuilt Motor Vehicle Inspector (PRVIP Inspector) to conduct rebuilt vehicle inspections at an authorized Florida Department of Highway Safety and Motor Vehicles (FLHSMV) Private Rebuilt Motor Vehicle Inspection Facility (PRVIP Facility) is required to attend an initial (24) hour Private Rebuilt Motor Vehicle Inspection training course provided by an approved FLHSMV Trainer.

The student will receive the necessary training that includes but is not limited to: identification of motor vehicles and their component parts, rebuilt vehicle title transfers and documents, National Motor Vehicle Title Information System (NMVTIS), and the Florida rebuilt vehicle statutes, policies and procedures. A certificate of completion shall be provided by the trainer to the student upon completion of the course.

The initial (24) hour training requirement will not be required for any person who participated in the 2013-2018 Pilot Rebuilt Vehicle Inspection Program and provides a copy of their certificate evidencing that they took the initial (24) hour training course. However, they will still be required to complete an (8) hour Inspector continuing education training course (described below) from an approved FLHSMV Trainer. The certificate of completion must be submitted to FLHSMV prior to conducting rebuilt vehicle inspections.

Continuing Education (8) Hour Rebuilt Vehicle Inspection Training

Annually, each Inspector shall complete an (8) hour Inspector Training continuing education course from an approved FLHSMV Trainer and submit a copy of the certificate of completion to FLHSMV. This shall be submitted by the approved PRVIP Facility along with the required annual renewal application. The (8) hour PRVIP Inspector continuing education course may be completed no more than (2) months prior to the end of the renewal period. The renewal period for an approved PRVIP Facility is from October 1 through September 30 each year.

The PRVIP Inspector (8) hour continuing education course shall provide a “refresher” on identification of motor vehicles and their component parts, Florida rebuilt vehicle title transfer and documents, NMVTIS, and related Florida Statutes, policies, and procedures. Additionally, the course shall provide an overview of any rebuilt inspection service concerns identified by FLHSMV through conducting onsite Facility Inspections for quality assurance and introduce any modifications to the rebuilt vehicle inspection program.

Special Note: Fingerprint background check receipt of completion must be submitted to the Regional Office prior to attending an initial an initial (24) hour Rebuilt Vehicle Inspection Training or (8) hour Continuing Education Rebuilt Vehicle Inspection Training.
